They also promote literacy by making free children's books, music and journals for self-reflection to youth ages 6 to 10 in schools in low income neighborhoods.

The Laxer Family Program promotes positive youth development through hospitality-related programs and scholarships, primarily in the Tampa Tampa Bay area. More than 430 youth were supported through a Laxer Family program or scholarship.

The mission of the David Hasbun Warrior X Project is to motivate and engage at risk youth by providing them with the tools that they need to be successful in life. Approximately 200 at risk youth were served in the Miami area during the year 2017.
